Financial Information

Undermentioned conditions apply for De Hoop Primary School as stipulated by the Governing Body. School Fees for 2024 are R23 705 per year. The 2025 School Fees will be decided at the Budget Meeting in October.

- 1. Both parents/guardians, jointly and individually, accept responsibility for payment of learner's school fees as determined by the Governing Body, irrespective of who enrolled the learner.
2. School fees are billed by 1 January and payable in advance before or on 28 February. The Governing Body has granted permission for fees to be paid in eleven equal monthly payments from 1 January to 1 November.
3. It is the sole responsibility of both parent(s)/guardian(s) to ensure that payment reaches the school on or before the payment date.
4. Should a payment be in arrear for more than 60 days, the Governing Body will take legal action to collect such debts. Both biological parents will be sent a final collection letter.
5. Should it be necessary for the school to instruct its attorneys to collect fees from the parent(s)/guardian(s), such parent(s)/guardian(s) shall be responsible for all attorney and client fees incurred whilst collecting such school fees as well as a collection commission.
6. A scheme exists whereby parents who reside in the feeder area of the school may apply for a full exemption or partial remission in respect of school fees, if their total gross annual household income is lower than a certain level determined by the Education Department.

By signing this application for exemption form, I/we give permission that De Hoop Primary may:-

- 6.1 make any reasonable enquiries to a credit bureau to verify any details provided by me/us on this application form at a registered credit bureau and to assess my application;
6.2 At any stage during the time that my/our children attend De Hoop and/or money is owing to De Hoop, to contact, request and obtain information (for the avoidance of doubt this includes any and all information held on my profile from a registered credit bureau to perform an assessment of my behaviour, indebtedness and creditworthiness and to continuously access my information from the credit bureau, for as long as there are money owing to De Hoop;
6.3 my/our information may be handed in to a registered credit bureau to report me/us as non-payer(s) if I/we do not make payments on time, as agreed with De Hoop. I/we are aware that in doing so, my/our credit profile can be negatively affected.
7. School fees are a statutory debt which is prescribed by law and may NOT be referred to a Debt Counsellor for debt review under section 129 of the National Credit Act. Schools are exempt from the National Credit Act.

I/We herewith bind myself / ourselves for the due fulfilment of all the above mentioned obligations and the payment of all school fees set out hereinbefore and levied from time to time.
